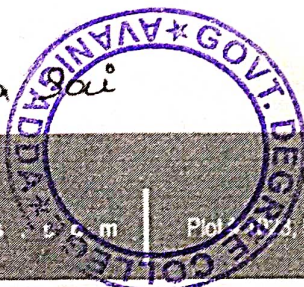
Offer Letter

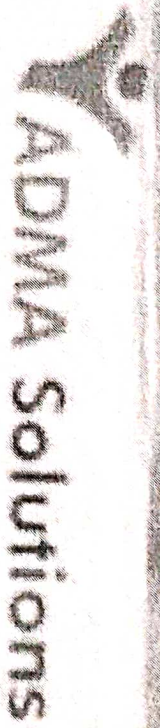
